

## Agreement on migration registration of citizens of Uzbekistan within 15 days after entering RF has been ratified 05.05.2022

Following our [news](#) we inform you that Federal Law No. 118-FZ "On ratification of the Agreement between the Government of the Russian Federation and the Government of the Republic of Uzbekistan on the procedure for the stay of citizens of the Russian Federation on the territory of the Republic of Uzbekistan and citizens of the Republic of Uzbekistan on the territory of the Russian Federation" was signed on May 1, 2022.

The law ratifies the Agreement between the Government of the Russian Federation and the Government of the Republic of Uzbekistan on the procedure for the stay of citizens of the Russian Federation on the territory of the Republic of Uzbekistan and citizens of the Republic of Uzbekistan on the territory of the Russian Federation, signed in Moscow on May 21, 2021 and in Tashkent on June 17, 2021, which provides that citizens of the state of one Party temporarily residing in the territory of the state of the other Party are exempted from the obligation to register (registration at the place of stay) with the competent authorities of the state of entry within 15 days from the date of entry.

Please note that the changes only apply to temporarily staying citizens and do not apply to temporarily or permanently residing foreign citizens. In addition, the agreement only refers to the terms of migration registration after entering the Russian Federation, the terms of migration registration when changing the place of stay or changing the permitted periods of stay specified during the previous migration registration have not changed.

For your convenience, we offer a timetable with the terms for migration registration of citizens of Uzbekistan in different situations.

<b>Temporary staying (without special statuses)</b>	within 15 days (from May 12, 2022, and 7 business days up to this point)	within 7 business days from the date of expiration of 30 days from the date of arrival at a new place of stay in the territory of the Russian Federation	not later than 3 business days from the date of the event
<b>Temporary residence permit (RVP)</b>	within 7 business days from the date of receiving the RVP (or register at the place of residence), annual confirmation of registration at the place of residence	within 7 business days from the date of expiration of 30 days from the date of arrival at a new place of stay in the territory of the Russian Federation	not later than 3 business days from the date of the event, if migration registration at the place of stay obtained
<b>Residence permit (RP)</b>	within 7 business days from the date of receiving the residence permit. Carry out registration at the place of residence, if the period of residence in the territory of the Russian Federation exceeds 3 years, annual confirmation of registration at the place of residence	within 7 business days from the date of expiration of 30 days from the date of arrival at a new place of stay in the territory of the Russian Federation	not later than 3 business days from the date of the event, if migration registration at the place of stay obtained
